

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0234

Affirmed
No Disqualification

PROCEDURAL HISTORY: On December 31, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct (decision # 133635). The employer filed a timely request for hearing. On February 14, 2019, ALJ M. Davis conducted a hearing, and on February 15, 2019 issued Order No. 19-UI-124781, affirming the Department's decision. On March 6, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record and the employer's written argument.¹ On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-124781 is affirmed.

¹ The employer argued that even if the employer's video evidence of claimant's alleged assault of her coworker was unclear, claimant's coworker's testimony should be considered credible evidence that claimant did in fact assault her coworker and claimant should be denied benefits. While claimant's coworker testified that she believed claimant had assaulted her, however, claimant testified that she did not, and, for the reasons explained in Order No. 19-UI-124781, the video evidence tended to support claimant's version of events because it did not substantiate that claimant moved or acted as the coworker alleged at the time of the incident. The employer had the burden of proof in this case, and did not prove through witness testimony or the video evidence that claimant more likely than not assaulted her coworker.
