

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0236

Affirmed
Disqualification

PROCEDURAL HISTORY: On December 3, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work with good cause (decision # 85549). The employer filed a timely request for hearing. On February 7, 2019, ALJ Frank conducted a hearing, and on February 15, 2019, issued Order No. 19-UI-124783, concluding claimant voluntarily left work without good cause. On March 5, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's written argument to the extent it was based on the record. The record does not support claimant's arguments for why he asserts he left work with good cause. Claimant argued that he quit work due to the effect of work stress on his health. Claimant's work conditions caused him stress that elevated his blood pressure and affected his liver function in late October 2018, however the record shows that claimant did not pursue the reasonable alternative of requesting time off work to help manage his stress or show that such an alternative was futile at the time he quit work. Claimant argued as well that he quit work due to the employer's failure to give claimant the accounts he anticipated receiving when he accepted a promotion to a different department in January 2018. Although claimant was dissatisfied with the accounts he received, the record does not show that it created a grave situation for claimant, who continued to receive a consistent income and did not allege that his income decreased. Nor does the record show that it is more likely than not that at the time claimant quit work, he was treated differently at work because of his race.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-124783 is affirmed.
