EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0246

Applications for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On March 3, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision #131533). On March 23, 2017, decision # 131533 became final without claimant having filed a timely request for hearing. On September 20, 2017, claimant filed a late request for hearing on decision # 131533. On September 21, 2017, the Department served notice of an administrative decision assessing a \$6,049 overpayment, \$907.35 monetary penalty, and 47 penalty weeks (decision # 193697). On October 4, 2017, OAH served notice of two hearings scheduled for October 18, 2017. On October 18, 2017, claimant failed to appear at the hearings, and ALJ S. Lee issued Order No. 17-UI-94874 and Order No. 17-UI-94875, dismissing claimant's requests for hearings on decision #131533 and decision #193697 due to claimant's failure to appear. On November 7, 2017, Order No. 17-UI-94874 and Order No. 17-UI-94875 became final without claimant having filed a request to reopen the hearings. On December 12, 2017, claimant filed a late request to reopen the hearings. On December 19, 2017, ALJ Kangas issued Order No. 17-UI-99309, and Order No. 17-UI-99311, denying claimant's request. On January 8, 2018, Order No. 17-UI-99309, and Order No. 17-UI-99311, became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 5, 2019, claimant filed a late application for review of Order No. 17-UI-99309 and Order No. 17-UI 99311 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders 17-UI-99309 and 17-UI-99311. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0247 and 2019-EAB-0246).

CONCLUSIONS AND REASONS: The applications for review should be dismissed.

¹ For reasons not explained in the record, the Office of Administrative Hearings (OAH) construed claimant's September 20, 2017 request for hearing as applying to decision # 193697, which was not issued until the day after claimant filed his request for hearing, and OAH's jurisdiction to review any issues related to decision # 193697 is therefore unclear. Ordinarily such a discrepancy would necessitate remand to determine the jurisdictional issue; however, given that the case must be procedurally dismissed anyway and in the interest of administrative efficiency we decline to do so.

On March 5, 2019, the appellant filed applications for review of Order No. 17-UI-99309 and Order No. 17-UI-99311 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the applications for review to be filed no later than November 7, 2017. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant submitted written materials to EAB with his application for review, but those materials included no explanation as to why the application was filed after the filing deadline expired. Accordingly, the applications for review are dismissed.

Order No. 17-UI-99309 and Order No. 17-UI-99311 remain undisturbed. EAB will take no further action with regard to these matters.

DECISION: The applications for review filed March 5, 2019 are dismissed. Order No. 17-UI-99309 and Order No. 17-UI-99311 remain undisturbed.
