

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0259

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On January 10, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 130533). Claimant filed a timely request for hearing. On February 7, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for February 21, 2019 at 8:15 a.m., at which time claimant failed to appear. On February 21, 2019, ALJ Griffin issued Order No. 19-UI-125025, dismissing claimant's request for hearing for failure to appear. On February 22, 2019, claimant filed a request to reopen. On February 28, 2019, ALJ Kangas reviewed claimant's request and issued Order No. 19-UI-125478, denying claimant's request to reopen. On March 12, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant failed to certify that she provided a copy of her argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). The argument also contained information that was not part of the hearing record, and failed to show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090 (October 29, 2006). We considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2). Even if we had considered claimant's additional information when reaching this decision the outcome of this case would remain the same because although claimant attempted to call into the February 21st hearing, her attempts occurred at 8:26 a.m., 8:33 a.m., 8:40 a.m., and 8:47 a.m. and claimant's argument did not establish that at 8:15 a.m. on February 21st she was prevented by an excusable mistake or circumstances beyond her reasonable control from participating in the scheduled hearing. Absent such evidence, good cause has not been shown.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-125478 is affirmed.
