

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0260**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On October 29, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from August 19 through October 13, 2018 (decision # 111039). On November 19, 2018, decision # 111039 became final without claimant having filed a request for hearing. On February 6, 2019, claimant filed a late request for hearing. On February 11, 2019, ALJ Kangas issued Order No. 19-UI-124409, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew her request by filing a response to an appellant questionnaire by March 4, 2019. On February 25, 2019, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on February 26, 2019, issued Order No. 19-UI-125349, re-dismissing claimant's late request for hearing as without good cause. On March 12, 2019, claimant filed a timely application for review of Order No. 19-UI-125349 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

**DECISION:** Order No. 19-UI-125349 is affirmed.
