

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0261

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On April 27, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was discharged for misconduct, and all benefit rights based on wages earned prior to the date of discharge shall be cancelled (decision # 145111). On May 17, 2018, decision # 145111 became final without claimant having filed a timely request for hearing. On February 1, 2019, claimant filed a late request for hearing. On February 6, 2019, ALJ Kangas issued Order No. 19-UI-124063, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by February 20, 2019. On February 14, 2019, claimant responded to the appellant questionnaire. ALJ Kangas reviewed claimant's response, and on February 19, 2019 issued Order No. 19-UI-124861, dismissing claimant's late request for hearing. On March 11, 2019, Order No. 19-UI-124861 became final without claimant having filed a timely application for review of the order with the Employment Appeals Board (EAB). On March 12, 2019, claimant filed a late request for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On March 12, 2019, the appellant filed an application for review of Order No. 19-UI-124861 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than March 11, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 19-UI-124861 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed March 12, 2019 is dismissed. Order No. 19-UI-124861 remains undisturbed.
