EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0264

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On November 28, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 84600). Claimant filed a timely request for hearing. On January 15, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 29, 2019. On January 29, 2019, claimant failed to appear at the hearing, and ALJ Murdock issued Order No. 19-UI-123595, dismissing claimant's request for hearing due to his failure to appear. Claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on February 26, 2019 issued Order No. 19-UI-125341, denying the request. On March 13, 2019, claimant filed a timely application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Order No. 19-UI-125341 is reversed and this matter remanded for completion of the hearing record, including an opportunity for claimant to respond to information contained in Department records.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. "Good cause" exists when the requesting party's failure to appear at the hearing arose from an excusable mistake or from factors beyond the party's reasonable control. OAR 471-040-0040(2) (February 10, 2012).

In Order 19-UI-125341, the ALJ concluded that claimant failed to establish good cause for failing to appear at the January 29, 2019 hearing. In support of that conclusion, the ALJ found that claimant contacted OAH on January 10th to report that he would not be able to participate in a hearing between January 18th and 27th, but agreed that he could participate in a hearing on or after January 28th, and was advised that OAH would send him a notice of hearing providing the information he needed to participate in the hearing.¹ The ALJ noted that, in accordance with OAR 471-040-0025(7), she was taking official

notice of that fact, which was contained in Department records.² However, those records are not part of the hearing record, and EAB does not have access to them. Nor was claimant given an opportunity to respond to the information contained in the records. Order No. 19-UI-125341 therefore is reversed as unsupported by the hearing record, and remanded for completion of the hearing record, including an opportunity for claimant to respond to the information contained in the Department's records.

DECISION: Order No. 19-UI-125341 is set aside, and this matter remanded for further proceedings consistent with this order.
