

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0267

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On August 21, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work during certain weeks between January 28, 2018 and August 18, 2018 (decision # 103147). On September 10, 2018, decision # 103147 became final without claimant having filed a timely request for hearing. On November 13, 2018, claimant filed a late request for hearing. On November 16, 2018, ALJ Kangas issued Order No. 18-UI-119840, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by November 30, 2018. On December 6, 2018, Order No. 18-UI-119840 became final without claimant having either responded to the questionnaire or filed a timely application for review of the order. On March 12, 2019, claimant filed a late application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On March 12, 2019, the appellant filed an application for review of Order No. 18-UI-119840 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than December 6, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-119840 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed March 12, 2019 is dismissed. Order No. 18-UI-119840 remains undisturbed.
