

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0278

Reversed and Remanded

PROCEDURAL HISTORY: On February 8, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant but not for misconduct (decision # 124849). The employer filed a timely request for hearing. On February 22, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for March 8, 2019. On March 8, 2019, ALJ Frank conducted a hearing, at which claimant failed to appear, and on March 15, 2019, issued Order No. 19-UI-126480, concluding claimant voluntarily left work without good cause. On March 18, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

With his application for review, claimant included a written statement arguing that he did not have a phone at the time of the hearing, and did not quit his job with the employer. Claimant's statement is construed as a request to have EAB consider new information under OAR 471-041-0090 (October 29, 2006), which allows EAB to consider information not presented at the hearing if the party offering the information shows it was prevented by circumstances beyond its reasonable control from presenting the information at the hearing. Claimant's statement, in and of itself, is inadequate to justify ordering a new hearing for the purpose of allowing claimant to present evidence about his work separation. It is, however, sufficient to warrant additional inquiry into claimant's reasons for missing the March 8th hearing. This matter is therefore set aside and remanded to OAH for a determination of whether or not claimant is entitled to have the hearing reopened. Only if claimant establishes good cause for missing the March 8th hearing would he then be allowed to present evidence about his work separation.

DECISION: Order No. 19-UI-126480 is set aside, and this matter remanded for additional proceedings consistent with this order.
