

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0287**

*Reversed & Remanded*

**PROCEDURAL HISTORY:** On February 8, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 90041). Claimant filed a timely request for hearing. On February 26, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for March 11, 2019. On March 11, 2019, ALJ Meerdink conducted a hearing, at which the employer failed to appear, and issued Order No. 19-UI-126158, concluding claimant's discharge was not for misconduct. On March 18, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

With its application for review, the employer submitted an argument asking that the March 11<sup>th</sup> hearing in this case be reopened. The employer's request is construed as a request to have EAB consider additional evidence under OAR 471-041-0090 (October 29, 2006), which allows EAB to consider new information if the party offering the information shows it was prevented by circumstances beyond its reasonable control from presenting the information at the hearing. In support of its request, the employer stated that it missed the March 11<sup>th</sup> hearing because although the notice of hearing was mailed on February 26, 2019, "it did not arrive at [the employer's business] until March 11<sup>th</sup> after 3:00 p.m." The employer did not offer any additional information about how the employer typically receives and processes mail, or the circumstances under which the employer did not receive the notice of hearing in this case until almost two weeks after it was mailed. We therefore cannot determine with any degree of certainty whether or not the employer's failure to receive notice of the hearing until after the hearing was held was or was not the result of circumstances beyond the employer's reasonable control, and conclude that additional evidence is necessary to make such a determination. This matter is therefore set aside and remanded to OAH for a hearing on the employer's request to reopen the March 11<sup>th</sup> hearing in this matter. Only if the employer establishes good cause to reopen would the employer then be entitled to present evidence about claimant's work separation.

**DECISION:** Order No. 19-UI-126158 is set aside, and this matter remanded for further proceedings consistent with this order.
