# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0288

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On February 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision #743326). Claimant filed a timely request for hearing. On February 22, 2019, the Office of Administrative Hearings (OAH) mailed the parties, including the employer at its address in Angoon, Alaska, notice of a hearing notice of a hearing scheduled for 9:30 a.m. Pacific Time. On March 4, 2019, ALJ F. Scott conducted a hearing at which the employer failed to appear, and on March 5, 2019 issued Order No. 19-UI-125754, concluding that claimant had good cause to quit working for the employer. On March 20, 2019, the employer filed a timely application for review of Order No. 19-UI-125754 with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** Order No. 19-UI-125754 is reversed and this matter remanded for another hearing and Order on whether claimant quit working for the employer with or without good cause.

In its application for review, the employer stated that it failed to appear at the March 4<sup>th</sup> hearing because it did not receive the February 22<sup>nd</sup> notice of hearing until the afternoon of March 4<sup>th</sup>, after the 9:30 a.m. hearing was over. The employer further stated it believed claimant should be disqualified from receiving benefits and wanted to explain the employer's point of view.

The employer's statements are construed as a request for consideration of new information regarding claimant's work separation under OAR 471-041-0090(2) (October 29, 2006). Under that rule, such information may be considered when the party offering the information establishes that factors or circumstances beyond the party's reasonable control prevented the party from offering the information into evidence at the hearing. In support of its request, the employer stated that it failed to receive the notice of hearing in time to appear at the hearing because it is located in rural Alaska, and the mail has to be flow in when weather permits. That statement is sufficient to establish that factors and circumstances beyond the employer's reasonable control prevented it from appearing at the hearing and offering its information into evidence at that time. The employer's request for consideration of new information therefore is allowed.

Order No. 19-UI-125754 therefore is reversed, and this matter remanded to OAH for a new hearing on whether claimant quit working for the employer with or with good cause, with sufficient notice to ensure that the employer receives it in time to appear despite the employer's remote location and the irregular manner in which its mail is delivered.

**DECISION:** Order No. 19-UI-125754 is set aside, and this matter remanded for further proceedings consistent with this order.
