

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0289

Affirmed
Disqualification

PROCEDURAL HISTORY: On November 1, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 72520). Claimant filed a timely request for hearing. On December 6, 2018, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled on December 13, 2018 at 8:15 a.m. On December 13, 2018, claimant failed to appear at the hearing and ALJ Kangas issued Order No. 18-UI-121165, dismissing claimant's request for hearing because claimant failed to appear at the hearing. On December 13, 2018, claimant filed a timely request to reopen the December 13, 2018 hearing. On February 4, 2019, OAH mailed notice of a hearing scheduled for February 21, 2019 to consider claimant's motion to reopen and, if the motion was allowed, whether claimant was disqualified from the receipt of benefits based on her work separation. On February 21, 2019, ALJ Kangas conducted a hearing, and on February 28, 2019, issued Order No. 19-UI-125529, allowing claimant's request to reopen and affirming decision # 72520 concluding that the employer discharged claimant for misconduct. On March 20, 2019, claimant filed an application for review the Employment Appeals Board.

Claimant submitted written argument to EAB, but failed to certify that she provided a copy of her argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Therefore, we considered the entire record, but did not consider claimant's argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-125529 is affirmed.
