

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0289-R

Request for Reconsideration Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On November 1, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 72520). Claimant filed a timely request for hearing. On December 6, 2018, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled on December 13, 2018 at 8:15 a.m. On December 13, 2018, claimant failed to appear at the hearing and ALJ Kangas issued Order No. 18-UI-121165, dismissing claimant's request for hearing because claimant failed to appear at the hearing. On December 13, 2018, claimant filed a timely request to reopen the December 13, 2018 hearing. On February 4, 2019, OAH mailed notice of a hearing scheduled for February 21, 2019 to consider claimant's motion to reopen and, if the request was allowed, whether claimant was disqualified from the receipt of benefits based on her work separation. On February 21, 2019, ALJ Kangas conducted a hearing, and on February 28, 2019, issued Order No. 19-UI-125529, allowing claimant's request to reopen and affirming decision # 72520, which concluded that the employer discharged claimant for misconduct. On March 20, 2019, claimant filed an application for review the Employment Appeals Board. On April 23, 2019, EAB issued EAB Decision 2019-EAB-0289. On May 20, 2019, the employer filed a late request for reconsideration with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: The request for reconsideration should be dismissed.

On May 20, 2019, the appellant filed a request for reconsideration with the Employment Appeals Board. A party may request reconsideration of an EAB decision to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rules, positions or practices. ORS 657.290(3); OAR 471-041-0145(1). A reconsideration request is subject to dismissal if filed more than 20 days from the date on which the EAB decision was served. OAR 471-041-0145(2)(b). The EAB decision at issue was served on April 23, 2019. 20 days from April 23, 2019 is May 13, 2019. The appellant's request for reconsideration was filed seven days late, on May 20, 2019. The reconsideration request is, therefore, dismissed as untimely.

DECISION: The request for reconsideration is dismissed. Order No. 19-UI-125529 remains undisturbed.
