

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0291**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On June 18, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$3,862.00 overpayment, \$579.30 monetary penalty, and 27 penalty weeks (decision # 203020). Claimant filed a timely request for hearing. On July 19, 2018, ALJ Wyatt conducted a hearing, and on July 23, 2018 issued Order No. 18-UI-113616, assessing a \$3,862.00 overpayment, \$579.30 monetary penalty, and 27 penalty weeks. On August 13, 2018, Order No. 18-UI-113616 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 15, 2019, claimant filed a late application for review of Order No. 18-UI-113616.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On March 15, 2019, the appellant filed an application for review of Order No. 18-UI-113616 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than August 13, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). Although claimant provided information disputing decision # 203020 and Order No. 18-UI-113616, he provided no explanation as to why he filed the application for review in this case approximately eight months after the filing deadline expired. Accordingly, the application for review is dismissed.

Order No. 18-UI-113616 remains undisturbed. EAB will take no further action with regard to this matter.

**DECISION:** The application for review filed March 15, 2019 is dismissed. Order No. 18-UI-113616 remains undisturbed.
