

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0299**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Overpayment*

**PROCEDURAL HISTORY:** On December 26, 2018, the Oregon Employment Department (the Department) issued notice of an administrative decision concluding that claimant was not available for work from October 28, 2018 through December 8, 2018 (decision # 133741). On January 15, 2019, decision # 133741 became final without claimant having filed a timely request for hearing.

On January 31, 2019, the Department issued notice of another decision concluding that the Department overpaid claimant \$789 in unemployment insurance benefits she was required to repay (decision # 110645). On February 13, 2019, claimant filed a late request for hearing on decision # 133741 and a timely request for hearing on decision # 110645.

On March 8, 2019, ALJ Janzen conducted two hearings, and on March 12, 2019, issued Order No. 19-UI-126223, dismissing claimant's late request for hearing on decision # 133741, and Order No. 19-UI-126225, affirming decision # 110645. On March 19, 2019, claimant filed timely applications for review of both order with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 19-UI-126223 and 19-UI-126225. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0298 and 2019-EAB-0299).

EAB reviewed the entire hearing record in both cases. On de novo review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

**DECISION:** Order Nos. 19-UI-126223 and 19-UI-126225 are affirmed.
