

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0307

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On February 8, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 114546). On February 13, 2019, claimant filed a timely request for hearing. On March 7, 2019, ALJ Snyder conducted a hearing, at which the employer failed to appear, and on April 4, 2019, issued Order No. 19-UI-126507, concluding claimant voluntarily left work without good cause. On March 26, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB considered the employer's argument in reaching this decision.¹

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On March 26, 2019, the Employment Appeals Board (EAB) received from the employer an application for review of an order that denied the claimant benefits. After reviewing Order No. 19-UI-126507 and the application for review, EAB has concluded that the employer's application for review must be dismissed. The employer based its application for review upon a belief that the ALJ's Order in this case, Order No. 19-UI-126507, overturned decision # 114546 and allowed claimant benefits. That belief is incorrect. Order No. 19-UI-126507 actually affirmed decision # 114546 and denied claimant benefits. The employer did not otherwise assign error to the ALJ's Order or request reversal of any portion of the decision. In consideration of our obligation to issue decisions that are consistent with sound principles governing judicial review and address only existing controversies between parties, we decline to address matters that will have no practical effect on the rights of the parties to the controversy. See *Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995); *Brunnett v. PSRB*, 315 Or 402, 848 P2d 1194 (1992).

¹ The employer requested that the hearing be reopened because neither it nor its representative received notice of the hearing in this case. The employer's request is construed as a request to submit additional evidence to EAB under OAR 471-041-0090. Under the circumstances the employer described this case might ordinarily require remand to the Office of Administrative Hearings for additional proceedings. Because the outcome of neither this decision nor the underlying decisions in this case were adverse the employer's interests for the reasons explained, however, we have not done so in this case.

Because the case before us presents no justiciable controversy, the application for review of Order No. 19-UI-126507 is dismissed. Order No. 19-UI-126507, which denies claimant benefits based upon her work separation from the employer, remains undisturbed.

DECISION: The application for review filed March 26, 2019 is dismissed. Order No. 19-UI-126507 remains undisturbed.
