# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0308

#### Affirmed Disqualification

**PROCEDURAL HISTORY:** On February 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant within 15 days of a planned voluntary leaving that would not have been for good cause (decision # 142547). Claimant filed a timely request for hearing. On March 14, 2019, ALJ Frank conducted a hearing, and on March 20, 2019 issued Order No. 19-UI-126675, affirming the Department's decision. On March 25, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted a written argument stating that "it seems that other anecdotal facts of this matter have gotten in the way of one plain detail; <u>I was terminated</u>" (emphasis in original). It appears that claimant's position is that because he was on a leave under the Family Medical Leave Act (FMLA) when the employer let him go, his discharge was wrongful. However, it is not clear what remedy claimant believes EAB may provide to him based on this allegedly wrongful discharge.

Order No. 19-UI-126675 found that the employer's discharge of claimant was not for misconduct, but that, since the discharge occurred within 15 days of a planned voluntary leaving not for good cause that claimant had already announced, he was disqualified from benefits. This disqualification resulted from the operation of ORS 657.176(8). ORS 657.176(8) plainly states that when an individual has notified an employer that the individual plans to leave work on a specific date for reasons that do not constitute good cause and the employer discharges the individual not for misconduct within 15 days of the planned voluntary leaving, the work separation shall be adjudicated as if the discharge had not occurred and the voluntarily leaving had occurred. However, the individual is eligible for benefits for the period including the week in which the discharge occurred through the week prior to the week of the planned voluntary leaving.

While claimant's discharge may not have been for misconduct (or may have been for improper reason(s)), Order No. 19-UI-126675 was correct in concluding that the reasons underlying claimant's announced voluntary leaving did not constitute good cause for leaving. Under these circumstances, ORS 657.176(8) must be applied, with the result that the discharge is ignored and the work separation is

treated as if the voluntary leaving had occurred for purposes of determining whether or not claimant is disqualified from benefits. Because the discharge occurred within the same week as the planned voluntary leaving, Order No. 19-UI-126675 correctly concluded that claimant was not entitled to receive benefits for any period of time due to the discharge not having been for misconduct.

The relief that EAB may grant on review is limited to that authorized under the statutes and regulations governing the circumstances under which unemployment insurance benefits may be allowed to claimants. On claimant's claim, that review is limited to whether or not he is disqualified from benefits, which was correctly determined in Order No. 19-UI-126675. EAB does not have the authority to provide other adjudicative remedies to claimant.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

**DECISION:** Order No. 19-UI-126675 is affirmed.
