EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0315

Affirmed Request to Reopen Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 16, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision # 93007). Claimant filed a timely request for hearing. On November 14, 2018, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for November 28, 2018. Claimant failed to appear at the hearing, and on November 29, 2018, ALJ Wyatt issued Order No. 18-UI-120429, dismissing claimant's request for hearing due to her failure to appear. Claimant filed a timely request to reopen the hearing. On December 31, 2018, OAH served notice of a hearing scheduled for January 14, 2019. On January 14, 2019, claimant failed to appear at the hearing, and ALJ Griffin issued Order No. 19-UI-122648, dismissing claimant's request to reopen due to her failure to appear. On February 4, 2019, Order No. 19-UI-122648 became final without claimant having requested to reopen January 14, 2019 hearing. On March 4, 2019, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on March 12, 2019, issued Order No. 19-UI-126189, denying the request. On March 28, 2019, claimant filed an application for review of Order No. 19-UI-126189 with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's request to reopen the January 14, 2019 hearing is dismissed.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. The period within which a party may request reopening may be extended if the party requesting reopening as good cause for failing to request reopening within the time allowed, and acts within a reasonable time. OAR 471-040-0041(1) (February 10, 2012). "Good cause" exists when an action, delay, or failure to act arises from an excusable mistake or from factors beyond an applicant's reasonable control. OAR 471-040-0041(2). "A reasonable time," is seven days after the circumstances that prevented a timely filing ceased to exist. OAR 471-040-0041(3). The party requesting reopening shall set forth the reason(s) for filing a late request to reopen in

a written statement, which OAH shall consider in determining whether good cause exists for the late filing, and whether the party acted within a reasonable time. OAR 471-040-0041(4).

In Order No. 19-UI-126189, the ALJ concluded that claimant filed a timely request to reopen the January 14th hearing.¹ However, Order No. 19-UI-122648, which dismissed claimant's request to reopen the November 28th hearing due to hear failure to appear, was issued on January 14th. Claimant's request to reopen the January 14th hearing was due by February 4th. Claimant did not file her request to reopen the hearing until March 4th. Claimant's request to reopen the hearing was late, and claimant did not set forth the reason(s) it was late in a written statement.

Claimant failed to show that her failure to file a timely request to reopen arose from an excusable mistake or from factors beyond her reasonable control, or that she filed her request to reopen within seven days after the circumstances that prevented a timely filing ceased to exist. She therefore failed to establish good cause for filing a late request to reopen, or that she filed her late request within a reasonable time.

Claimant's request to reopen the January 14, 2019 hearing is dismissed.

DECISION: Order No. 19-UI-126189 is affirmed.
