

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0316

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On April 30, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 91445). On May 21, 2018, decision # 91445 became final without claimant having filed a timely request for hearing. On February 25, 2019, claimant filed a late request for hearing. On March 4, 2019, ALJ Kangas issued Order No. 19-UI-125668, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by March 18, 2019. On March 25, 2019, Order No. 19-UI-125668 became final without claimant having either responded to the questionnaire or filed a timely application for review of the order. On March 28, 2019, claimant responded to the appellant questionnaire, and ALJ Kangas issued a letter dismissing claimant's request for hearing and stating Order No. 19-UI-125668 remained in effect. Also on March 28, 2019, claimant filed a late application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On March 28, 2019, the appellant filed an application for review of Order No. 19-UI-125668 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(c) required the application for review to be filed no later than March 25, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although claimant included with his application for review a copy of the questionnaire explaining why he filed his request for hearing on decision # 91445 late, he provided no explanation as to why the application was filed after the filing deadline expired. In the absence of such an explanation, the application for review is dismissed under OAR 471-041-0070(3). Order No. 19-UI-125668 remains undisturbed. EAB will take no further action with regard to this matter.

DECISION: The application for review filed March 28, 2019 is dismissed. Order No. 19-UI-125668 remains undisturbed.
