

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0337

Affirmed
Request to Reopen Dismissed

PROCEDURAL HISTORY: On December 10, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant benefits for the week of October 14 through 20, 2018 (decision # 153533). Claimant filed a timely request for hearing. On December 26, 2018, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 8, 2019. Claimant failed to appear at the hearing, and on January 9, 2019, ALJ Janzen issued Order No. 19-UI-122352, dismissing claimant's request for hearing due to his failure to appear. On January 29, 2019, Order No. 19-UI-122352 became final without claimant having filed a request to reopen the hearing. On March 20, 2019, claimant filed a late request to reopen the hearing. ALJ Kangas reviewed claimant's request, and on March 26, 2019 issued Order No. 19-UI-127058, dismissing the request as late without a showing of good cause. On March 29, 2019, claimant filed a timely application for review of Order No. 19-UI-127058 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record and claimant's written argument. However, claimant's argument contained new information that is not relevant to the issue before us, whether claimant had good cause for failing to file a timely request to reopen the January 8th hearing on decision # 153533. EAB therefore did not consider claimant's new information when reaching this decision. *See* OAR 471-041-0090 (October 29, 2006).

On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-127058 is affirmed.
