

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0343-R

Request for Reconsideration Dismissed
EAB Decision 2019-EAB-0343 Remains Undisturbed
No Disqualification

PROCEDURAL HISTORY: On February 20, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 94503). Claimant filed a timely request for hearing. On March 13, 2019, ALJ Scott conducted a hearing, and on March 20, 2019 issued Order No. 19-UI-126741, concluding that claimant's discharge was not for misconduct. On April 2, 2019, the employer filed an application for review with the Employment Appeals Board (EAB). On May 9, 2019, EAB issued EAB Decision 2019-EAB-0343, affirming Order No. 19-UI-126741. On May 17, 2019, the employer filed a request for reconsideration of EAB Decision 2019-EAB-0343.

CONCLUSIONS AND REASONS: The employer's request for reconsideration of EAB Decision 2019-EAB-0343 is dismissed.

Any party may ask EAB to reconsider its decision to correct an error of material fact or law, or to explain any unexplained inconsistency with Department rule, or officially stated Department position, or prior Department practice. OAR 471-041-0145(1) (May 13, 2019). However, the request is subject to dismissal unless it includes a statement that a copy has been provided to the other parties. OAR 471-041-0145(2)(a). Here, the employer's request for reconsideration of EAB Decision 2018-EAB-0517 did not include a statement that a copy of the request had been provided to the claimant as required. The employer's request for reconsideration therefore is dismissed.

Even if the employer's request for reconsideration was allowed, however, EAB Decision 2019-EAB-0343 would be adhered to on reconsideration. In its request, the employer did not assign any error of material fact or law, or request an explanation of any unexplained inconsistencies with Department rule, official stated positions or prior practice, as required by OAR 471-041-0145(1). In addition, the employer offered additional evidence that the employer had not offered into evidence at the hearing. Under OAR 471-041-0090(2)(b), EAB could only consider that additional evidence if the employer established that "[f]actors or circumstances beyond the party's reasonable control prevented the party from offering the information into evidence at the hearing." The employer's request for reconsideration

did not address why the employer failed to submit the evidence at the hearing, and therefore did not show that it was prevented from doing so by factors or circumstances beyond its reasonable control. Therefore, even if EAB had allowed the employer's request for reconsideration, EAB could not have considered the additional evidence, and the outcome of this case would have remained the same.

DECISION: The request for reconsideration filed May 17, 2019 is dismissed. EAB Decision No. 2019-EAB-0343 remains undisturbed.
