

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0345

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On February 14, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 152558). On March 6, 2019, decision # 152558 became final without claimant having filed a timely request for hearing. On March 18, 2019, claimant filed a late request for hearing. On March 21, 2019, ALJ Kangas reviewed claimant's request and issued Order No. 19-UI-126810, dismissing claimant's late request for hearing. On April 3, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant did not certify that she provided a copy of her argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). Therefore, we did not consider the argument when reaching this decision. Even if we had, the outcome of this decision would remain the same. Although understandable, errors of the sort that caused claimant to overlook the places on decision # 152558 that specified the March 6, 2019 deadline – even though small and human – are not the sort of errors that amount to good cause under ORS 657.875 and OAR 471-040-0010. Absent a showing of good cause as defined in ORS 657.875 and OAR 471-040-0010, there is no basis in Oregon law under which claimant's late request for hearing may be allowed.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-126810 is affirmed.
