

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0398

Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACTS: On March 7, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from February 3 through March 2, 2019 (decision # 151851). Claimant filed a timely request for hearing. On March 26, 2019, ALJ Schmidt conducted a hearing, and on April 2, 2019 issued Order No. 19-UI-127467, concluding that claimant was available for work from February 3 through March 23, 2019. On April 19, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 19-UI-127467 presents no justiciable controversy, and therefore is dismissed.

Claimant appealed an order that found her eligible for benefits. In her application for review, claimant did not assign error to any portion of the order, nor did she request reversal of any part of the order. In consideration of EAB's obligation to issue decisions that are consistent with sound principles governing judicial review and address only existing controversies between parties, we decline to address matters that will have no practical effect on the rights of the parties to the controversy. *See Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995); *Brunnett v. PSRB*, 315 Or 402, 848 P2d 1194 (1992).

DECISION: The application for review filed April 19, 2019 is dismissed. Order No. 19-UI-127467 remains undisturbed.
