EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0405

Reversed & Remanded

PROCEDURAL HISTORY: On March 5, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$5,956 overpayment, \$1,786.80 monetary penalty, and 48 penalty weeks. On March 25, 2015, that decision became final without claimant having filed a timely request for hearing. On March 12, 2019, claimant filed a late request for hearing. On March 18, 2019, ALJ Kangas issued Order No. 19-UI-126538, dismissing claimant's late request for hearing subject to her right to renew the request by responding to an appellant questionnaire by April 1, 2019. On March 29, 2019, claimant responded to the request. On April 8, 2019, ALJ Kangas issued Order No. 19-UI-127790, re-dismissing claimant's late request for hearing. On April 24, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: This matter is set aside, and remanded for additional proceedings.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Claimant stated in the appellant questionnaire that she did not file a timely request for hearing because someone else claimed benefits under her name, and her mother hid mail from her so she never received the administrative decision assessing the overpayment and penalties. The Order in this case disregarded claimant's explanations and decided the case based solely on the unsupported finding that claimant "knew, from her phone conversations with the Employment Department in October 2016, of the administrative decision and that she was penalized 48 weeks of future benefits." *See* Order No. 19-UI-127790 at 2.

The Order must be set aside because there is absolutely no record evidence establishing the existence of an October 2016 phone call between the Department and claimant, nor is there any indication of the source of any evidence supporting that finding. Even if there was, for example, a Department record suggesting that such a phone call took place, the use of conclusions or inferences drawn from such a record as dispositive evidence, without requiring that the evidence be substantiated or allowing the adversely affected party a meaningful opportunity to respond, amounts to a denial of due process.

ORS 657.270 requires the ALJ to give all parties a reasonable opportunity for a fair hearing. That obligation necessarily requires the ALJ to ensure that the record developed at the hearing shows a full and fair inquiry into the facts necessary for consideration of all issues properly before the ALJ in a case. ORS 657.270(3); see accord Dennis v. Employment Division, 302 Or 160, 728 P2d 12 (1986). Because the ALJ failed to develop the record Order No. 19-UI-127790 is reversed, and this matter is remanded for development of the record.

DECISION: Order No. 19-UI-127790 is set aside, and this matter remanded for further proceedings consistent with this order.
