EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0409

Reversed & Remanded

PROCEDURAL HISTORY: On March 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision # 122709). Claimant filed a timely request for hearing. On March 26, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for April 9, 2019. On April 9, 2019, ALJ Hall conducted a hearing, at which the employer did not appear, and issued Order No. 19-UI-127816, concluding claimant quit working for the employer with good cause. On April 25, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

In its application for review, the employer requested a new hearing. The employer's request is construed as a request for EAB to consider additional information under OAR 471-041-0090(2), which allows EAB to consider new information only if it is relevant and material to EAB's determination, and factors or circumstances beyond the party's reasonable control prevented the party from offering the information into the hearing record. In support of the employer's request, the employer stated that the employer was not aware of the scheduled hearing because, "No notice was received by Paychex [the employer's representative] or the client company [the employer]."

The employer's statement suggests that the lack of notice of hearing might have amounted to a factor or circumstance beyond the employer's reasonable control that prevented it from participating in the hearing and offering evidence about claimant's work separation. However, the employer did not provide enough detail to allow its request for consideration of additional information, and further inquiry is required. This matter is therefore set aside and remanded for a hearing on whether or not the employer has good cause to reopen the April 9 hearing.

On remand, the employer should be prepared to testify as to its address of record with the Department, including whether it the representatives' address or the P.O. Box address to which the administrative decision and notice of hearing were mailed. The employer should also be prepared to testify if the P.O. Box address, to which the administrative decision and the notice of hearing were mailed to, was the

employer's actual mailing address, and if so, why did the employer nevertheless failed appear at the hearing.

The ALJ should ask any additional questions necessary to develop a full record as to whether or not the employer has good cause to reopen the hearing. Only if the employer shows good cause to reopen the hearing would the employer then be entitled to a hearing about the work separation.

DECISION: Order No. 19-UI-127816 is set aside, and this matter remanded for further proceedings consistent with this order.
