

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0418

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 1, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct (decision # 104021). The employer filed a timely request for hearing. On March 22, 2019, the Office of Administrative Hearings (OAH) served, by mail, notice of a hearing scheduled for April 5, 2019. On April 5th, ALJ Murdock conducted a hearing at which claimant failed to appear, and on April 9, 2019, issued Order No. 19-UI-127858 concluding that claimant's discharge was for misconduct. On April 26, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Order No. 19-UI-127858 is reversed and this matter remanded for another hearing on whether claimant should be disqualified from receiving benefits based on her discharge by the employer.

In her application for review, claimant stated that she failed to appear at the April 5th hearing because she forgot where she put the March 22nd notice of hearing after receiving it in the mail, and therefore forgot about the hearing until she received Order No. 19-UI-127858 in the mail. Claimant's statement is construed as a request, due to her failure to appear at the hearing, for consideration of new information regarding her discharge by the employer. Under OAR 471-041-0090(2) (October 29, 2006), claimant's information may be considered if she establishes that factors or circumstances beyond her reasonable control prevented her from appearing at the hearing and offering her information into evidence at that time.

Claimant explained in her application for review that she has difficulty remembering things due to physical and mental health issues resulting from a 2014 head injury and the death of her daughter in 2018. According to claimant, she forgets, among other things, doctor appointments, how old her children are, personal appointments, names and numbers of roads she is familiar with, her son's phone number, job interviews, career fair appointments, and to pay her bills. Claimant's explanation is sufficient to establish that factors and circumstances beyond her reasonable control caused her to forget

about the April 5th hearing, and therefore prevented her from appearing at the hearing and offering information into evidence at that time.

Claimant's request for consideration of new information regarding her discharge by the employer therefore is granted. Order No. 19-UI-127858 is reversed and this matter remanded for another hearing on whether claimant should be disqualified from receiving benefits.

DECISION: Order No. 19-UI-127858 is set aside, and this matter remanded for further proceedings consistent with this order.
