EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0422

Reversed & Remanded

PROCEDURAL HISTORY: On January 14, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$4,016 overpayment that claimant was required to either repay or have deducted from future benefits payable during the five year period after the week in which the decision became final (decision # 121758). On February 4, 2019, decision # 121758 became final without claimant having filed a timely request for hearing. On March 29, 2019, claimant filed a late request for hearing. On April 9, 2019, ALJ Kangas issued Order No. 19-UI-127827, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by April 23, 2019. On April 25, 2019, claimant responded to the appellant questionnaire and filed a timely application for review with the Employment Appeals Board (EAB). On April 29, 2019, ALJ Kangas mailed a letter stating that claimant's response was late and therefore would not be considered. This matter therefore comes before EAB based upon claimant's April 25, 2019 application for review.

CONCLUSIONS AND REASONS: Order No. 19-UI-127827 is set aside and this matter remanded.

With his application for review, claimant submitted a copy of his appellant questionnaire response, which contained new information about his late request for hearing. EAB may consider a party's new information if the information is relevant and material to the issue before EAB, and if factors or circumstances beyond the party's reasonable control prevented the party from presenting that information to the ALJ. *See* OAR 471-041-0090(2).

The information claimant provided to EAB was that he filed a late request for hearing in this case because he was homeless, did not receive mail, and did not know about the decision until he received notice of a garnishment. That information is relevant and material to the issue before EAB. The information claimant provided to EAB stated that he is still homeless and experiencing difficulty collecting his mail, which is a factor or circumstance beyond his reasonable control that prevented him from responding to the appellant questionnaire within the designated time period. Claimant is therefore entitled to present new information about his late request for hearing.

Claimant's new information – the appellant questionnaire response – is admitted into evidence as EAB Exhibit 1. Any party that objects to our doing so must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(3) (October 29, 2006). Unless such objection is received and sustained, the exhibit will remain in the record.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The new information claimant provided to EAB suggests that he might have had good cause for filing a late request for hearing in this case. However, additional evidence is necessary before a determination can be reached about whether he had good cause for the late request for hearing, and, if so, whether he filed his late request for hearing within the seven-day "reasonable time" period. This matter is therefore set aside because the record is incomplete, and remanded to the Office of Administrative Hearings for a hearing on the late request for hearing issue. Only if claimant establishes at the hearing that he had good cause for the late request within a reasonable time would he be entitled to a hearing on the merits of decision # 121758.

DECISION: Order No. 19-UI-127827 is set aside, and this matter remanded for further proceedings consistent with this order.
