

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0427

Affirmed
Request to Reopen Granted
Late Request for Hearing Allowed
Late Claims for Benefits Denied

PROCEDURAL HISTORY: On December 28, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed his claims for the weeks of July 8, 2018 through July 28, 2018 late, and therefore denying claimant benefits for those weeks (decision # 80118). On January 17, 2019, decision # 80118 became final without claimant having filed a request for hearing. On January 23, 2019, claimant filed a late request for hearing.

On February 6, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 20, 2019 on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 80118. On February 20, 2019, claimant failed to appear at the hearing, and ALJ Lee issued Order No. 19-UI-124923, dismissing claimant's request for hearing due to his failure to appear. On March 11, 2019, claimant filed a timely request to reopen the hearing.

On March 19, 2019, OAH served notice of a hearing scheduled for April 1, 2019 on whether claimant's request to reopen should be granted and, if so, whether his late request for hearing on decision # 80118 should be allowed and, if so, the merits of that decision. On April 1, 2019, ALJ Monroe conducted a hearing, and on April 9, 2019 issued Order No. 19-UI-127864, allowing claimant's request to reopen, allowing his late request for hearing on decision # 80118, and affirming that decision, but misstating the period for which claimant was denied benefits.

On April 15, 2019, ALJ Monroe issued an Order No. 19-UI-128164, amending Order No. 19-UI-127864 by correcting the period for which claimant was denied benefits. On April 29, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**

DECISION: Order No. 19-UI-128164 is affirmed.
