

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0429

Affirmed
No Disqualification

PROCEDURAL HISTORY: On February 25, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for committing a disqualifying act under the Department's Drug and Alcohol Policy (decision # 150842). The employer filed a timely request for hearing on decision # 150842. On March 8, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 150842 scheduled for March 21, 2019 (Case No. 2019-UI-92879).

On March 12, 2019, the Department served notice of an amended administrative decision cancelling decision # 150842 and concluding the employer discharged claimant but not for misconduct connected with work (decision # 90027). OAH cancelled the hearing scheduled for March 21, 2019 and closed Case No. 2019-UI-92879 because it mistakenly believed that the Department issued a dismissal of the employer's hearing request in that case when it issued decision # 90027. On March 25, 2019, OAH concluded that because decision # 90027 did not resolve all of the issues raised in decision # 150842, the hearing scheduled for March 21, 2019 should not have been cancelled and Case No. 2019-UI-92879 should not have been closed. Accordingly, OAH reopened Case No. 2019-UI-92879, and on March 27, 2019, served notice of a new hearing on decision # 150842 scheduled for April 5, 2019.

On April 5, 2019, ALJ Shoemake conducted a hearing on decision # 150842 that was continued on April 18, 2019. On April 29, 2019, ALJ Shoemake issued Order No. 19-UI-128946, affirming decision # 150842. On May 1, 2019, the employer filed an application for review of Order No. 19-UI-128946 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.

DECISION: Order No. 19-UI-128946 is affirmed.
