EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0436

Affirmed Request to Reopen Denied

PROCEDURAL HISTORY: On March 25, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the week of March 3 through 9, 2019 (decision # 71938). Claimant filed a timely request for hearing. On April 11, 2019, the Office of Administrative Hearings (OAH) served notice of a telephone hearing scheduled for April 25, 2019. On April 25th, claimant failed to appear at the hearing, and on April 26, 2019, ALJ Monroe issued Order No. 19-UI-128847, dismissing claimant's request for hearing due to his failure to appear. Claimant filed a timely request to reopen the hearing. ALJ Kangas reviewed claimant's request, and on May 2, 2019 issued Order No. 19-UI-129202, denying the request. On May 6, 2019, claimant filed an application for review of Order No. 19-UI-129202 with the Employment Appeals Board (EAB).

Claimant submitted written argument with his application for review. EAB considered claimant's written argument to the extent it was based on the hearing record, and relevant and material to whether claimant's request to reopen the April 25th hearing should be granted. *See* OAR 471-041-0090 (October 29, 2006).

FINDING OF FACT: The April 11, 2019 notice of hearing stated that the telephone hearing on decision # 71938 was scheduled for Thursday, April 25, 2019 at 2:30 p.m., at which time claimant was required to call in to the hearing. Claimant failed to appear at the hearing because he mistakenly believed it was scheduled for Friday, April 26, 2019. Claimant was working as a truck driver, Monday through Friday, and it is difficult for him to make sure he is available for a hearing without taking the entire day off from work.

CONCLUSIONS AND REASONS: Claimant's request to reopen the April 25th hearing is denied.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. "Good cause" exists when the requesting party's

failure to appear at the hearing arose from an excusable mistake or from factors beyond the party's reasonable control. OAR 471-040-0040(2) (February 10, 2012).

Claimant failed to appear at the April 25th hearing because he mistakenly believed it was scheduled for Friday, April 26, 2019. However, claimant failed to show that it was beyond his reasonable control to read and understand from the notice of hearing that the hearing was scheduled for April 25th. And although claimant's belief that the hearing was scheduled for April 26th was a mistake, it was not an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

And finally, although claimant was working as a truck driver and it is difficult for him to make sure he is available for a hearing without taking the entire day off, he did not assert or show that that would have prevented him from appearing at the hearing on April 25th, as he apparently intended to do on April 26th.

Claimant failed to establish good cause for failing to appear at the April 25th hearing. His request to reopen the hearing therefore is denied.

DECISION: Order No. 19-UI-129202 is affirmed.
