EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0449

Reversed Disqualification

PROCEDURAL HISTORY: On March 19, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision #81756). Claimant filed a timely request for hearing. On April 15, 2019, ALJ Monroe conducted a hearing at which the employer did not appear, and on April 23, 2019 issued Order No. 19-UI-128645, concluding claimant voluntarily left work with good cause. On May 10, 2019, the Department filed an application for review with the Employment Appeals Board (EAB).

The order under review erroneously states that no exhibits were offered or admitted into evidence at hearing. Exhibit 1 was marked and admitted into the record at hearing. Exhibit 1 is a statement from claimant and claimant's October 12, 2018 letter of intent to purchase Twist Cocktail Catering Company. Audio Record 6:39 to 7:08, Exhibit 1. EAB considered the entire hearing record and the Department's written argument in reaching this decision.

FINDINGS OF FACT: (1) Barnes – Noble Booksellers USA Inc. employed claimant as a café server from June 2018 until November 1, 2018. During that time, claimant lived in Eugene, Oregon.

- (2) On October 12, 2018, claimant signed a letter of intent to purchase the assets of a catering company in Bend, Oregon. The letter of intent stated that the closing date for the sale would be November 7, 2018 or other date agreed upon by claimant and the seller. Exhibit 1. The parties agreed to try to close the sale no later than December 31, 2018. Exhibit 1.
- (3) On October 17, 2018, claimant told the employer she planned to quit work on November 1, 2018.

(4) On November 1, 2018, claimant quit work because she needed time to acquire and finalize the business documents to purchase the catering company, and to prepare to move her home from Eugene to Bend on November 10, 2018, where she would begin running the catering company.

CONCLUSIONS AND REASONS: Claimant voluntarily left work without good cause.

A claimant who leaves work voluntarily is disqualified from the receipt of benefits unless they prove, by a preponderance of the evidence, that they had good cause for leaving work when they did. ORS 657.176(2)(c); *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). "Good cause . . . is such that a reasonable and prudent person of normal sensitivity, exercising ordinary common sense, would leave work." OAR 471-030-0038(4) (December 23, 2018). The standard is objective. *McDowell v. Employment Department*, 348 Or 605, 612, 236 P3d 722 (2010). A claimant who quits work must show that no reasonable and prudent person would have continued to work for their employer for an additional period of time. Leaving work without good cause includes leaving work for self-employment. OAR 471-030-0038(5)(b)(G).

The order under review, Order No. 19-UI-128645, applied the standard set forth in OAR 471-030-0038(4) and concluded that claimant had good cause to quit because a reasonable and prudent person would have quit when she did to prepare to move to Bend to start her new business. However, as stated in OAR 471-030-0038(5)(b)(G), leaving work without good cause includes leaving work for self-employment. Claimant quit work to pursue self-employment in Bend. Because leaving work for self-employment constitutes quitting work without good cause, claimant quit work without good cause and is disqualified from receiving unemployment insurance benefits based on this work separation.

DECISION: Order No. 19-UI-128645 is set aside, as outlined above.
