# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0452

#### Affirmed Ineligible Weeks 05-19 Through 11-19

**PROCEDURAL HISTORY:** On March 22, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from January 27, 2019 until the reason for claimant's denial ended (decision # 133704). Claimant filed a timely request for hearing. On April 15, 2019, ALJ Wyatt conducted a hearing, and on April 23, 2019, issued Order No. 19-UI-128651, concluding claimant was not available for work from January 27, 2019 through March 16, 2019 (weeks 05-19 through 11-19). On May 13, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted written argument to EAB. Claimant asserted that he was ineligible for unemployment insurance benefits because "going to school meant [he] wasn't able to accept work during school hours."<sup>1</sup> Claimant argues that this is incorrect because he did not refuse a job during the weeks at issue, and currently has a full time job while attending school to obtain his GED.<sup>2</sup> Even though claimant is able to work full time by pursuing a GED or finding a job that does not conflict with his school schedule, to have been eligible for benefits from January 27 through March 16, 2019, claimant had to show that he was available for work during *all the days and hours customary for a line cook in his labor market area* during that time period. The customary hours for a line cook included the day shift, which conflicted with his school hours during that time period. There was the possibility that claimant might have found work that did not conflict with his school schedule, and he did not refuse work during the weeks at issue. However, the fact that claimant's school schedule conflicted with the customary work hours for a line cook and claimant told potential employers that he was a student, his attending school limited the scope of jobs claimant was available to accept. In other words, because claimant was attending school, he was not available for all potential work of the type sought in his labor market.

EAB reviewed the entire hearing record and claimant's written argument. On *de novo* review and pursuant to ORS 657.275(2), the Order under review is **adopted**.
