

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0454**

*Reversed & Remanded*

**PROCEDURAL HISTORY:** On October 24, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 104349). Claimant filed a timely request for hearing. On December 4, 2018, January 3, 2019, January 23, 2019, February 28, 2019, and April 24, 2019, ALJ Wyatt conducted a hearing, and on May 1, 2019 issued Order No. 19-U-129161, concluding claimant was employed by the employer until his discharge, not for misconduct. On May 9, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** This matter is set aside as unsupported by a complete record, and remanded to the Office of Administrative Hearings (OAH) for such other proceedings as are necessary.

ORS 657.275 provides that EAB shall review the record of the case and promptly affirm, modify, or set aside the order of the ALJ if the Director of the Department or any interested party files a timely application for review. To perform such review, EAB needs a complete record from OAH. Upon preliminary review of this matter, it appears that the parties submitted twelve different sets of documents to the ALJ, including duplicates. The ALJ marked ten sets of documents as exhibits, and the ALJ admitted nine sets of documents into evidence. However, none of the documents in the voluminous record compiled during a hearing held on five separate dates were accurately marked; although approximately five sets of documents bear a "plaintiff's exhibit" stamp, those stamps do not correspond to the exhibit numbers assigned to those documents as orally described on the record, and no other documents were marked. The record is therefore incomplete. EAB cannot accurately determine from the record which documents are exhibits and which are not; accordingly, the record is not sufficient for EAB to review. Because there is not a complete record for EAB to review in this matter, and it appears that further proceedings are or may be necessary before the record can be provided, Order No. 19-UI-

129161 is reversed as unsupported by a complete record, and the case remanded for such other and further proceedings as may be necessary.

**DECISION:** Order No. 19-UI-129161 is set aside, and this matter remanded for further proceedings consistent with this order.
