

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0460

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On April 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$1,077 overpayment, a \$323.10 monetary penalty, and 7 penalty weeks (decision # 194042). On April 24, 2019, decision # 194042 became final without claimant having filed a request for hearing. On April 25, 2019, claimant filed a late request for hearing. On May 1, 2019, ALJ Kangas issued Order No. 19-UI-129124, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by May 15, 2019. On May 7, 2019, claimant filed a timely response to the questionnaire. ALJ Kangas reviewed claimant's response, and on May 9, 2019 issued Order No. 19-UI-129613 re-dismissing claimant's late request for hearing. On May 14, 2019, claimant filed timely applications for review of Order No. 19-UI-129613 with the Employment Appeals Board (EAB).

Claimant did not certify that he provided a copy of his written argument to the other parties as required by OAR 471-041-0080(2)(a) (October 29, 2006). The argument also contained information that was not part of the hearing record, and failed to show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information into the record as required by OAR 471-041-0090 (October 29, 2006). We therefore did not consider claimant's argument when reaching this decision. *See* ORS 657.275(2).

Even if we had considered claimant's written argument, the outcome of this decision would remain the same. Claimant wrote in his argument that he did not file a timely request for hearing on decision # 194042 because he did not see the filing deadline stated in the decision. However, claimant failed to show that it was beyond his reasonable control to see that the filing deadline was April 24, 2019, and his failure to do so was not an excusable mistake because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply. Claimant's written argument therefore fails to establish good cause to extend the filing deadline, and claimant's late request for hearing still would be subject to dismissal. *See* ORS 657.875 and OAR 471-040-0010.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is **adopted**.

DECISION: Order No. 19-UI-129613 is affirmed.
