

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0461

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On March 13, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from February 3, 2019 to March 9, 2019 (decision # 121559). Claimant filed a timely request for hearing. On April 16, 2019, ALJ Wyatt conducted a hearing, and on April 24, 2019 issued Order No. 19-UI-128705, concluding claimant was not available for work from February 3, 2019 to March 16, 2019. On May 14, 2019, Order No. 19-UI-128705 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 15, 2019, claimant filed a late application for review of Order No. 19-UI-128705 with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On May 15, 2019, the appellant filed an application for review of Order No. 19-UI-128705 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than May 14, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed May 15, 2019 is dismissed. Order No. 19-UI-128705 remains undisturbed.
