

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0479

Affirmed
Disqualification

PROCEDURAL HISTORY: On April 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision # 122406). Claimant filed a timely request for hearing. On May 9, 2019, ALJ Murdock conducted a hearing, and on May 17, 2019 issued Order No. 19-UI-130137, affirming the Department’s decision. On May 22, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record and claimant’s written argument to the extent it was based on information received into evidence at the hearing. *See* ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019). In his argument, claimant complained, in part, that Order No. 19-UI-130137 focused on the employer’s failure to grant him a pay raise as the reason he quit work, and not on other factors that influenced his decision to quit. As correctly stated in Order No. 19-UI-130137, however, claimant testified at hearing that he would not have quit work when he did if he had received a raise.¹ Claimant also testified that not receiving a raise was the “main” reason he quit work, the “final incident” that prompted him to quit, and his “primary issue” with the employer.² Order No. 19-UI-130137 therefore properly focused on the employer’s failure to grant claimant a raise as the reason he quit.

On *de novo* review and pursuant to ORS 657.275(2), Order No. 19-UI-130137 is **adopted**.

DECISION: Order No. 19-UI-130137 is affirmed.
