**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0503**

*Affirmed*  
*Late Request for Hearing Allowed*  
*Ineligible*

**PROCEDURAL HISTORY:** On March 18, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was unable to work during the week of February 3 through February 9, 2019, and therefore is ineligible for benefits for that week (decision # 91612). On April 8, 2019, decision # 91612 became final without claimant having filed a request for hearing. On April 9, 2019, claimant filed a late request for hearing. On April 17, 2019, ALJ Kangas issued Order No. 19-UI-128380, dismissing claimant's request for hearing subject to her right to renew the request by filing a response to an appellant questionnaire by May 7, 2019. Claimant filed a timely response to the appellant questionnaire. On April 30, 2019 the Office of Administrative Hearings (OAH) cancelled Order No. 19-UI-128380, and on May 1, 2019 scheduled a hearing for May 15, 2019 on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 91612. On May 15, 2019, ALJ Scott conducted a hearing, and on May 22, 2019 issued Order No. 19-UI-130336, allowing claimant's request for hearing and modifying decision # 91612 by concluding that claimant was unable to work during the weeks of February 3 through March 9, 2019, and therefore is ineligible for benefits for those weeks. On May 31, 2019, claimant filed a timely application for review of Order No. 19-UI-130336 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-130336 is affirmed.
