EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0507

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On March 21, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 95915). Claimant filed a timely request for hearing. On April 4, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for April 18, 2019. On April 18, 2019, ALJ Snyder conducted a hearing at which the employer failed to appear, and on April 26, 2019 issued Order No. 19-UI-128897, concluding that claimant voluntarily left work with good cause. On May 13, 2019, the employer filed a timely request to reopen the hearing. On May 14, 2019, ALJ Kangas reviewed the employer's request and issued Order No. 19-UI-129856, denying the request. On June 3, 2019, the employer filed a timely application for review of Order No. 19-UI-129856 with the Employment Appeals Board (EAB).

The employer did not declare in their written argument that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information about the employer's reopen request that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information into the hearing record, as required by OAR 471-041-0090 (May 13, 2019). EAB therefore considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-129856 is affirmed.
