

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0509**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On February 26, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was able, available, and actively seeking work from January 20, 2019 through February 16, 2019 (decision # 81851). On March 18, 2019, decision # 81851 became final without the employer having filed a timely request for hearing. On May 10, 2019, the employer filed a late request for hearing. On May 21, 2019, ALJ Kangas issued Order No. 19-UI-130264, dismissing the employer's late request for hearing subject to their right to renew the request by responding to an appellant questionnaire by June 4, 2019. The employer chose not to respond to the appellant questionnaire. On June 1, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

With the employer's application for review, the employer submitted a written argument that stated, "I received your response, I am not asking for a hearing, but I want a review why [claimant] will receive benefits for the following reasons, which your department failed to explain to me." The argument then listed several reasons why the employer disagreed with decision # 81851. However, the employer is not entitled to dispute an administrative decision, or entitled to an explanation of why benefits were allowed to claimant beyond the explanation contained in decision # 81851, unless the employer either files a timely request for hearing or establishes good cause to file a late request for hearing. The employer did not do either of those things in this case. Therefore, the employer's information about claimant's ability and availability for work cannot be considered at this time, nor, since the employer is not entitled to a hearing on claimant's ability and availability for work, can we explain why claimant's benefits should or should not be allowed.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-130264 is affirmed.
