

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0517

Affirmed
Disqualification

PROCEDURAL HISTORY: On April 12, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision # 142702). Claimant filed a timely request for hearing. On May 14, 2019, ALJ Scott conducted a hearing, and on May 20, 2019, issued Order No. 19-UI-130217, affirming the Department's decision. On June 6, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: During the May 14, 2019 hearing, the employer sent to the Office of Administrative Hearings (OAH) an audio recording of the voice message claimant sent to the employer's Human Resources office after she left the job on her last day of work. The audio recording was not received into the record during the hearing because its transmission was unknown and the record was not left open to receive the exhibit at the employer's request. OAR 471-041-0090(1)(a) (May 13, 2019) provides that EAB may consider information not received into evidence at the hearing if necessary to complete the record. The audio recording is relevant to the work separation and its admission into evidence is necessary to complete the record in this case. Accordingly, the recording, previously marked as Exhibit 1, is admitted into the record. EAB will make an electronic copy of the recording available via email to any party that requests one. If any party objects to the admission of Exhibit 1 into the record, that party must submit such objection to this office in writing, setting forth the basis of the objection, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, Exhibit 1 will remain in the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-130217 is affirmed.
