

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0537

Affirmed
Ineligible Weeks 10-19 and 12-19

PROCEDURAL HISTORY: On April 25, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from March 3, 2019 through March 9, 2019 (week 10-19), because he missed a suitable work opportunity on March 8, 2019 (decision # 105206). On April 25, 2019, the Department served notice of another administrative decision concluding claimant was not available for work from March 17, 2019 through the March 23, 2019 (week 12-19), because he missed a suitable work opportunity on March 22, 2019 (decision # 105747). Claimant filed a timely request for hearing on both decisions. On May 20, 2019, ALJ Snyder conducted a consolidated hearing, and on May 28, 2019 issued Order No. 19-UI-130655 affirming decision # 105206, and Order No. 19-UI-130647 affirming decision # 105747. On June 6, 2019, claimant filed timely applications for review of both Orders with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order No. 19-UI-130655 and Order No. 19-UI-130647. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0536 and 2019-EAB-0537).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

DECISION: Order No. 19-UI-130647 and Order No. 19-UI-130647 are affirmed.
