# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0546

Reversed & Remanded

**PROCEDURAL HISTORY:** On March 18, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$6,841 overpayment, \$2,052.30 monetary penalty, and 52 penalty weeks (decision # 194361). Claimant filed a timely request for hearing. On March 27, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for April 10, 2019 at 10:45 a.m., at which time claimant failed to appear for the hearing. On April 10, 2019, ALJ R. Frank issued Order No. 19-UI-127920, dismissing claimant's request for hearing for failure to appear. On April 17, 2019, claimant filed a request to reopen the April 10<sup>th</sup> hearing. On April 25, 2019, OAH mailed notice of the reopen hearing scheduled for May 10, 2019 at 10:45 a.m., at which time claimant failed to appear for the hearing. On May 10, 2019, ALJ Meerdink issued Order No. 19-UI-129718, dismissing claimant's request to reopen for failure to appear. On May 29, 2019, claimant filed a request to reopen the May 10<sup>th</sup> hearing. On June 4, 2019, ALJ Kangas reviewed claimant's request and issued Order No. 19-UI-131031, denying the request. On June 14, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant's written argument is admitted into evidence under OAR 471-041-0090(1) (May 13, 2019). The additional evidence has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDINGS OF FACT:** Claimant missed the May 10<sup>th</sup> hearing because she was taking prescription medication that made her oversleep. At all relevant times, the medication resulted in claimant being in a depressed state and having short-term memory problems.

**CONCLUSIONS AND REASONS:** Order No. 19-UI-131031 is set aside and this matter remanded.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. "Good cause" exists when the requesting party's failure to appear at the hearing arose from an excusable mistake or from factors beyond the party's reasonable control. OAR 471-040-0040(2) (February 10, 2012).

Order No. 19-UI-131031 concluded claimant did not have good cause to reopen the May 10<sup>th</sup> hearing because she did not submit a statement explaining why she missed that hearing. It appears likely on review, and in consideration of EAB Exhibit 1, that claimant failed to explain why she missed the hearing because she was experiencing adverse side effects to prescription medication. Under the circumstances, claimant is entitled to a hearing on her request to reopen the May 10<sup>th</sup> hearing.

The parties should note that the principal issue for the remand hearing will be claimant's request to reopen the May 10<sup>th</sup> hearing. Only if claimant shows good cause to reopen the May 10<sup>th</sup> hearing would her request to reopen the April 10<sup>th</sup> hearing be at issue. And only if claimant shows good cause to reopen the April 10<sup>th</sup> issue would claimant then be entitled to a hearing on the merits of decision # 194361.

**DECISION:** Order No. 19-UI-131031 is set aside, and this matter remanded for further proceedings consistent with this order.
