

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0555

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 29, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully failed to report her work separation from the employer to obtain benefits, must repay \$2,478 in benefits she received, is disqualified for 16 weeks of future benefits, and assessed a \$371.70 monetary penalty (decision # 201581). On February 19, 2019, decision # 201581 became final without claimant having requested a hearing. On April 27, 2019, claimant filed a late request for hearing. On May 6, 2019, ALJ Kangas issued Order No. 19-UI-129377, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew her request by filing a response to an appellant questionnaire by May 20, 2019. On May 24, 2019, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 19-UI-129377 with the Employment Appeals Board (EAB).

Claimant submitted her response to the appellant questionnaire with her application for review of Order No. 19-UI-129377. EAB admitted claimant's response into the record as EAB Exhibit 1 under OAR 471-041-0090(1)(a) (May 13, 2019), which allows EAB to receive additional evidence into the record if necessary to complete the record. EAB considered EAB Exhibit 1 when reaching this decision, and a copy of EAB Exhibit 1 is attached. Any party that objects to the admission of EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, EAB Exhibit 1 will remain in the record.

CONCLUSIONS AND REASONS: Claimant's late request for hearing on decision # 201581 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable

control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

In the present case, claimant did not explain in her request for hearing on decision # 201581 why it was almost 3 months late. Exhibit 2. In her response to the appellant questionnaire, claimant explained why her response was late, but she did not explain why her request for hearing was late. EAB Exhibit 1. Claimant therefore failed to establish good cause for filing her request for hearing late. Claimant’s late request for hearing on decision # 201581 therefore is dismissed.

DECISION: Order No. 19-UI-129377 is affirmed.
