

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0560

Affirmed
Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 3, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant actively sought work during the week of April 28 through May 4, 2019, and allowing claimant benefits for that week if otherwise eligible (decision # 123209). Claimant filed a timely request for hearing. On June 10, 2019, ALJ Kangas issued Order No. 19-UI-131366, dismissing claimant's request for hearing as presenting no justiciable controversy because decision # 123209 was not adverse to claimant, and a hearing would not have a practical effect on claimant's rights or interests because decision # 123209 ruled in claimant's favor. On June 14, 2019, claimant filed an application for review of Order No. 19-UI-131366 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

However, we note that on May 23, 2019, the Department served notice of a separate administrative decision concluding that claimant quit working for River Forks Market Inc. without good cause, and was disqualified from receiving benefits, effective April 21, 2019, and until an employer(s) paid him 4 times his weekly benefit amount for work in future weeks (decision # 134935). Claimant filed a timely request for hearing, and on June 12, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 134935 scheduled for June 24, 2019 at 1:30 p.m.

This EAB decision has no effect on the Department's decision that claimant is disqualified from receiving benefits, effective April 21, 2019, based on his work separation from River Forks Market Inc. If claimant has any questions about that matter or his June 24th hearing, he must contact the Department or the Office of Administrative Hearings.

DECISION: Order No. 19-UI-131366 is affirmed.
