EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0561

Affirmed
No Disqualification

PROCEDURAL HISTORY: On May 6, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 150453). Claimant filed a timely request for hearing. On June 10, 2019, ALJ Meerdink conducted a hearing, and on June 12, 2019 issued Order No. 19-UI-131549, concluding that claimant's discharge was not for misconduct. On June 19, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record and the employer's written argument. In its written argument, the employer asserted that Order No. 19-UI-131549 erred in focusing exclusively on claimant's failure on March 7, 2019 to apologize for his behavior on March 5, 2019 to determine whether he was discharged for misconduct, and not also on the behavior itself. As noted in Order No. 19-UI-131549, however, the employer's witness testified that if claimant had apologized on March 7th for his behavior on March 5th, the employer would have allowed him to continue working. Audio Record at 10:19-10:25. That testimony is corroborated by the witness' written statement that the final incident that caused claimant's discharge was his failure to apologize for his behavior. Exhibit 1 at 3.

Order No. 19-UI-131549 therefore did not err in initially focusing on claimant's failure to apologize to determine whether he was discharged for misconduct. If claimant's failure to apologize had been willful or wantonly negligent, his behavior on March 5th would have been relevant to whether his failure to apologize was misconduct, or an isolated incident of poor judgment under OAR 471-030-0038(1)(d) and (3)(b) (December 23, 2018). However, the record supports the order's conclusion that claimant's failure to apologize was not willful or wantonly negligent, and addressing claimant's behavior on March 5th therefore was unnecessary.

Even if claimant's behavior on March 5th had been the final incident resulting in his discharge, the outcome would remain the same. Although willful or wantonly negligent, the record fails to show it was a repeated act or pattern of other willful or wantonly negligent behavior, and the employer's willingness to allow claimant to continue working if he had apologized shows that it did not make a continued employment relationship impossible. *See* OAR 471-030-0038(1)(d)(A) and (D). The record therefore

fails to establish that claimant's behavior on March 5th was misconduct, and not an isolated instance of poor judgment.

On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-131549 is affirmed.
