EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0572

Affirmed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On April 5, 2019, the Oregon Employment Department (the Department) served, by mail, notice of an administrative decision concluding that claimant quit work without good cause (decision # 140642). On April 25, 2019, decision # 140642 became final without claimant having filed a request for hearing. On May 2, 2019, claimant filed a late request for hearing. On May 10, 2019, ALJ Kangas issued Order No. 19-UI-129694, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew her request by filing a response to an appellant questionnaire within 14 days. On May 30, 2019, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 19-UI-129694 with the Employment Appeals Board (EAB). On June 10, 2019, ALJ Kangas issued a letter stating that because claimant's response to the appellant questionnaire was filed late, it would not be considered, another order would not be issued, and Order No. 19-UI-129694 remained in effect.

EAB considered claimant's response to the appellant questionnaire under OAR 471-041-0090(1) (May 13, 2019). Claimant's response to the appellant questionnaire has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects the admission of EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) Claimant received decision # 140642 shortly after April 5, 2019. *See* EAB Exhibit 1 at 1.

(2) Decision stated # 140642 that to be timely, any appeal from the decision had to be filed on or before April 25, 2019. Exhibit 1. Claimant did not file a request for hearing until May 2, 2019.

CONCLUSIONS AND REASONS: Claimant's late request for hearing on decision # 140642 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Here, claimant filed her request for hearing on decision # 140642 seven after the filing deadline. In her response to the appellant questionnaire, claimant asserted that she filed a late request for hearing because she "was sick and had trouble getting out." EAB Exhibit 1 at 2. However, she did not provide any information as to when she became ill or how long she was ill for, or explain how being ill interfered with her ability to file a timely request for hearing. Without this information, EAB is unable to determine if claimant's illness occurred before or after she received the decision, whether or not it lasted through the filing deadline, or how it prevented her from requesting a hearing by the filing deadline.

Furthermore, when asked what prompted her to file a request for hearing on May 2, 2019, claimant responded that it was because she "kept getting denied for unemployment." EAB Exhibit 1 at 2. Claimant's response suggests that she continued to file for unemployment benefits during her illness. From this, EAB infers that claimant was able to conduct some part of her business during her illness, and, therefore, that it was also within her reasonable control to file a timely request for hearing. Based on this evidence, claimant failed to show good cause to extend the deadline for filing a request for hearing on decision # 140642 to May 2, 2019.

Claimant's late request for hearing on decision # 140642 therefore is dismissed.

DECISION: Order No. 19-UI-129694 is affirmed.
