

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0576

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 19, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was overpaid \$471 in benefits for the week of April 22 through 28, 2018 (decision # 75443). On April 8, 2019, decision # 75443 became final without claimant having filed a request for hearing. On April 17, 2019, claimant filed a late request for hearing. On April 30, 2019, ALJ Kangas issued Order No. 19-UI-129018, dismissing claimant's late request for hearing, subject to his right to renew his request by filing a response to an appellant questionnaire by May 14, 2019. On May 17, 2019, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 19-UI-129018 by the Employment Appeals Board (EAB). On June 5, 2019, ALJ Kangas issued a letter stating that because claimant filed his response to the appellant questionnaire late, it would not be considered, another order would not be issued, and Order No. 19-UI-129018 remained in effect.

EAB considered claimant's response to the appellant questionnaire under OAR 471-041-0090(1) (May 13, 2019). Claimant's response to the appellant questionnaire has been marked as EAB Exhibit 1. Any party that objects the admission of EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Claimant's late request for hearing on decision # 75443 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

In his response to the appellant questionnaire, claimant stated that he filed his request for hearing on decision # 75443 late because he did not receive the decision until May 2019. However, claimant filed his request for hearing on April 17, 2019, so he was aware of decision # 75443 on or before that date. Claimant did not state when he first became aware of the decision in his request for hearing or his response to the appellant questionnaire. Absent that information, we cannot find good cause for claimant's late request for hearing, or that claimant filed his request for hearing within a reasonable time after any circumstances that prevented a timely filing ceased to exist.

Claimant's late request for hearing on decision # 75443 therefore is dismissed.

DECISION: Order No. 19-UI-129018 is affirmed.
