

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0586

Affirmed
No Disqualification

PROCEDURAL HISTORY: On May 28, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 103704). Claimant filed a timely request for hearing. On June 19, 2019, ALJ Murray-Roberts conducted a hearing, and on June 24, 2019 issued Order No. 19-UI-132158, concluding that claimant's discharge was not for misconduct. On June 26, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

The employer submitted written argument with their application for review. However, EAB did not consider the employer's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

However, even if EAB considered the employer's argument, the outcome of this decision would remain the same. In their argument, the employer complained that Order 19-UI-132158 considered only the final incident(s) of claimant's alleged insubordination, and not prior incidents. However, the order did not err in initially focusing on the final incident(s) resulting in claimant's discharge to determine whether it was for misconduct. If claimant's behavior during the final incident(s) had been shown to be insubordinate, prior incidents of alleged insubordination would have been relevant to whether her behavior during the final incident(s) was misconduct, or excusable as an isolated instance of poor judgment under OAR 471-030-0038(1)(d) and (3)(b) (December 23, 2018). However, the record supports the order's conclusion that claimant's behavior during the final incident(s) was not shown to be insubordinate, and considering claimant's behavior during prior incidents therefore was unnecessary.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-132158 is affirmed.
