

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0587

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On February 19, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 141759). Claimant filed a timely request for hearing. On March 14, 2019, ALJ R. Frank conducted a hearing, and on March 20, 2019 issued Order No. 19-UI-126673, affirming the Department's decision. On April 9, 2019, Order No. 19-UI-126673 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 25, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On June 25, 2019, the appellant filed an application for review of Order No. 19-UI-126673 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 9, 2019. The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b).

Claimant stated in her application for review that she filed late because she disagreed with Order No. 19-UI-126673 and had "just learned about needing to appeal this judgment call." However, Order No. 19-UI-126673 stated on page 3 that claimant could appeal the decision by filing an application for review, that the deadline for filing was 20 days after the date the order was mailed, and referred to some enclosed instructions about how to appeal that included EAB's contact information if she had questions about filing an application for review. The order's certificate of mailing stated, "Any appeal from this Order must be filed on or before April 9, 2019 to be timely." The order also included a fill-in-the-blank style application for review form. Given that the order contained instructions for filing an application for review, the deadline to file an application for review, and an application for review form, in the absence of information explaining why it was beyond her reasonable control to file a timely application for review, claimant has not met her burden to show good cause. Claimant's late application for review is therefore dismissed.

DECISION: The application for review filed June 25, 2019 is dismissed. Order No. 19-UI-126673 remains undisturbed.
