

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0588

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On February 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 91504). Claimant filed a timely request for hearing. On March 8, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for March 19, 2019, at which time claimant failed to appear. On March 19, 2019, ALJ Scott issued Order No. 19-UI-126649, dismissing claimant's hearing request for failure to appear. On April 4, 2019, claimant filed a timely request to reopen the March 19th hearing. On April 10, 2019, ALJ Kangas considered claimant's request and issued Order No. 19-UI-127948, denying claimant's request to reopen. On April 30, 2019, Order No. 19-UI-127948 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 24, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On June 24, 2019, the appellant filed an application for review of Order No. 19-UI-127948 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 30, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although the appellant included a written statement with his application for review, that statement provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed June 24, 2019 is dismissed. Order No. 19-UI-127948 remains undisturbed.
